ORDINANCE NO. 430

**AN ORDINANCE OF THE BOROUGH OF ST. CLAIR,  
SCHUYLKILL COUNTY, PENNSYLVANIA, DESIGNATING  
THE 200 BLOCK OF SOUTH MILL STREET AS A TEMPORARY  
ONE-WAY STREET, BETWEEN EAST RAILROAD STREET  
AND EAST PATTERSON STREET, FOR THIRTY (30) MINUTES  
BEFORE THE START OF EACH SCHOOL DAY.**

The Borough Council of the Borough of St. Clair, Schuylkill County, Pennsylvania (the "Borough"), hereby enacts and ordains as follows:

WHEREAS, Section 1201 of the Borough Code, 53 P.S. §46201, entitled "General Powers", authorizes the Borough to make and adopt ordinances necessary for the proper management, care and control of the Borough, and the maintenance of the health and welfare of the Borough and its citizens; and

WHEREAS, Section 1202 of the Borough Code, 53 P.S. §46202, entitled "Specific Powers", authorizes the Borough to adopt ordinances to secure the safety of persons or property within the Borough, and to regulate traffic to promote the convenience and protection of the public; and

WHEREAS, Section 6109(a)(4) of the Pennsylvania Motor Vehicle Code, 75 Pa.C.S.A. § 6109, acknowledges that the Borough can reasonably exercise its police power by designating particular roadways for use by traffic moving in one direction.

NOW THEREFORE, BE IT ENACTED AND ORDAINED BY the Borough Council of the Borough of St. Clair, Schuylkill County, Pennsylvania, in accordance with the general powers permitted by the Borough Code (53 P.S. §46201, et seq.) and the statutes noted above, as follows:

**Section 101. Title.**

This Ordinance shall be known as the "St. Clair Borough Traffic Ordinance for South Mill Street".

**Section 102. Citation**

This Ordinance may be cited as the "St. Clair Borough Traffic Ordinance for South Mill Street".

**Section 103. Purpose.**

The purpose of this Ordinance is to protect the public health, safety and welfare by designating the 200 block of South Mill Street as one-way traffic to accommodate the arrival of students who are transported by private vehicle or who walk to school.

**Section 104. Establishment of Temporary One-Way Traffic.**

For thirty (30) minutes before the start of each school day, traffic shall be one way north on the 200 block of South Mill Street. Temporary signs shall be placed by the St. Clair Area School District at the appropriate times to accommodate this temporary traffic regulation. St. Clair Area School District shall also provide four (4) staff members who would be stationed in the areas to assist in the traffic control. St. Clair Area School District shall also provide a portable Roll-n-Pole Do Not Enter sign in order to establish the appropriate one-way direction.

**Section 105. Inapplicable to Official Borough Vehicles.**

The provisions of this Ordinance shall not apply to vehicles belonging to the Borough of St. Clair, which are marked with the Official Seal of the Borough of St. Clair on the side thereof.

**Section 106. Severability.**

The provisions of this Ordinance are severable, and if any section, clause, sentence, part or provision thereof shall be held to be illegal, invalid or unconstitutional by any court of competent jurisdiction, such decision of the court shall not affect, impair or invalidate any of the remaining sections, clauses, sentences, parts or provisions of this Ordinance. It is hereby declared to be the intent of St. Clair Borough Council that this Ordinance would have been adopted if such illegal, invalid or unconstitutional section, clause, sentence, part or provision had not been included herein.

**Section 107. Repealer/Savings.**


The provisions of any prior ordinance which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency. Nothing contained in this Ordinance shall be construed to affect any suit or proceeding in any court, or any rights acquired or liability incurred, or any cause of action existing prior the enactment of this Ordinance. Nothing contained in this Ordinance establishing parking zone restrictions shall be construed to permit parking vehicles in those spaces within any zone in which by other ordinances of the Borough or state law parking is prohibited.

Section 108. Effective Date.

This Ordinance shall become effective immediately after the adoption hereof.
