Therefore, The Odd Fellows Cemetery Association was chartered in 1866 to create a new community cemetery since the existing cemetery, now known as the Borough Cemetery was nearly full. The following is the status of engineering services performed by our firm as of this date:

#### **ENGINEERING CONSULTATIONS & CONSTRUCTION PROJECTS**

#### Little League Field Development (31226.20)

After the final plans are approved by DCNR, we will be able to advertise the project with the hope of receiving bids in December. Construction will take place next year at a time that is preferrable to the Little League.

#### **Northward Court Improvements**

Although the Borough was awarded a DCNR grant to resurface the Northward basketball courts and improve drainage, the Borough cannot begin work on design until the official notice to proceed is received from DCNR. It is possible that the courts could be resurfaced late in the 2023 paving season.

#### 113 East Hancock Street Demolition (31311.70, Task 2)

We anticipate advertising to receive bids at the December Council Meeting, although demolition over the winter months might not be preferred as there are tenants living in the adjoining house. Additionally, if another property is under consideration for demolition, it is typically more economical to advertise the demolition projects together under one contract.

#### 2022 Crack Sealing (31311.02, Task 3)

The Contractor – Asphalt Maintenance Solutions, LLC (AMS) – began work on October 31, 2022, and work is being coordinated with the Borough Superintendent. All work should be completed this week, although they have until November 18, 2022, to complete the work.

#### Strauss Corrective Action Plan (31311.02, Task 3)

On October 7, 2022, Ms. Amy Strauss provided our office with a copy of the Corrective Action Plan & Erosion Control Plan for Amy Strauss prepared by HNT Engineering & Surveying (revised 09/29/2020). Our office spoke with Ms. Strauss on October 10, 2022, and restated the Borough's position that the plan as presented is acceptable to the Borough, although it is preferred to have the new inlet installed behind the curb instead of on the street side. Regardless, the Borough is not committing any funds to construct these improvements. Ms. Strauss also requested the Borough consider installing an inlet at the cul-de-sac. Our office indicated that the drainage design is not based on her request, although if Ms. Strauss and her engineer wanted to prepare an alternate drainage design, the Borough would consider that design.



#### FY2022 COPS Hiring Program (CHP; 31311.02, Task 5)

On October 14, 2022, the Borough was notified via email from the US Department of Justice that the Borough was not selected for funding, noting that demand "far exceeded the funding available under the program this year." Applications were evaluated using the data provided in the application and further assessed on the key factors as follows:

- Reported local crime data
- Current commitment to community policing
- Planned community policing activities
- Demonstrated need for federal assistance, including poverty and unemployment rates

There was a total of 180 awards across the United States with 4 being from Pennsylvania: Ambridge Borough, Pittston City, Pocono Township, and Wilkes Barre City.

## PA Commission on Crime and Delinquency (PCCD): Local Law Enforcement (LLE) Support Grant Program (31311.02, Task 5)

With the assistance from the Borough Police Chief and Borough Secretary, on October 13, 2022, our office submitted a grant application to PCCD for equipment and technological upgrades totaling \$177,018. Grant awards are anticipated to be announce on December 14, 2022.

#### John Siney Park (31311.02, Task 5)

As requested by Council, on October 27, 2022, our office submitted a grant application to PA DCNR for improvements at their John Siney Park and Playground. This project will replace old play equipment, remove several trees, and install ADA-compliant paved walkways around the park. Total estimated project costs are \$125,000 with \$25,000 (20%) being a Borough match. The anticipated award notification is in January 2023.

#### SUBDIVISIONS & LAND DEVELOPMENTS

#### STS LD (31137.31, Task 1)

The developer's engineer provided the following update on October 31, 2022:

Fence installation is about 90% complete. The remaining fencing to be installed is in locations where other work is still in progress. The project is slated to be complete by the end of November, and STS is looking to move into the new facility in December.

#### AutoZone LD (31137.31, Task 3)

At your March 1, 2022, Council Meeting, Conditional Final Plan Approval was granted by Council with the major conditions being the PennDOT Driveway HOP, the PennDOT Stormwater HOP, and the Development Agreement. We are awaiting the Applicant to prepare a draft of the Development Agreement for our review.
