ORDINANCE NO. 444

**AN ORDINANCE OF THE BOROUGH OF ST. CLAIR,  
SCHUYLKILL COUNTY, PENNSYLVANIA, AMENDING THE  
ST. CLAIR BOROUGH POLICE PENSION PLAN TO ALLOW  
FOR THE PURCHASE OF CREDIT FOR MILITARY SERVICE.**

WHEREAS, the Borough of St. Clair ("Employer"), on January 1, 1960, established a retirement plan for certain of its employees known as the Borough of St. Clair Police Pension Plan (the "Prior Plan");

WHEREAS, Employer now desires to allow for the purchase of credit for military service under certain conditions; and

WHEREAS, Employer has the authority, pursuant to 53 P.S. § 767, to establish, regulate and maintain police pension funds.

NOW THEREFORE, BE IT ENACTED AND ORDAINED that, effective as of June 6, 2023, the St. Clair Borough Police Pension Plan is amended to include the following provision:


Purchase of Credit for Military Service. Full service credit for each year of military service or fraction thereof, not to exceed five (5) years is hereby authorized for any member of the Police Force who was not employed by the Borough of St. Clair prior to such military service. The amount due for the purchase of credit for military service other than intervening military service shall be computed by applying the average normal cost rate for municipal police pension plans as certified by the Public Employee Retirement Study Commission, but not to exceed ten (10) per centum, to the member's average annual rate of compensation over the first three (3) years of municipal service and multiplying the result by the number of years and fractional part of a year of creditable non intervening military service being purchased together

with interest at the rate of four and three-quarters (4-3/4%) per centum compounded annually from the date of initial entry into municipal service to the date of payment.

Effective Date. This Ordinance shall become effective immediately after the adoption hereof.
