

ISSUES, REVIEW & FINANCE WORK SESSION

June 29, 2023

A special meeting of the St. Clair Borough Council was held to review issues and finance on Thursday, June 29, 2023, beginning at 6:30 p.m.

In attendance were council members: Joann Brennan, Cheryl Dempsey, Thomas Dempsey, Tony Klazas, William Dempsey, and Mayor Tomko. Absent were Thomas Adamchick and Judy Stednitz-Julian.

Others in attendance included Borough Secretary Roland Price, Treasurer Carol Sutzko, Barbara Artz, Electric Light Superintendent Bob Petrozino, and Police Chief William Dempsey via a phone conference.

Chief Dempsey discussed the possibility of conducting a non-competitive Sergeant's Civil Service Test to officially promote Brad Blanner as Sergeant. Officer Brad Blanner is the only eligible officer to have the qualifications to apply for the Sergeant's position. Attorney Brennan will be consulted on the civil service requirements.

Public Comment

No public comment.

President Dempsey acknowledged the great job the Police Civil Service Commission does. It is impressive and very organized. We couldn't ask for a better committee.

Mayor Tomko requested that the council make a motion on Wednesday to add to the monthly newsletter the illegal use of cones and chairs to save parking spots. He also asked council to consider an ordinance prohibiting campers and trailers from parking on the Borough streets. He questioned if there is already an ordinance in place prohibiting the automobile repairs on a public street, which will be posed to Attorney Brennan at Wednesday's council meeting. He recommended the Sanitation Department conduct a "study" to determine how many residents are not using garbage receptacles. Mayor Tomko commended the Electric Light Department for being on top of the electronic blips we received recently. Maybe we should consider putting pressure on PPL to make sure the problem is handled. Council should also consider printing in the monthly newsletter about illegally parked vehicles, but we should first check with Chief Dempsey about the verbiage.

Electric Light Superintendent Bob Petrozino [provided an explanation of the sensitivity tolerance of the lines coming into town causing the blips. He has contacted PPL; they are currently working with the borough to alleviate the problem in the future.

Illegal parking throughout town is a concern for the safety of drivers, especially at many intersections. Due to number of complaints and the safety hazard, council decided to post some guidelines in the newsletter.

Superintendent Petrozino met with Comcast and resolved the last issue of poles on Ann Street. Wright Contracting was to provide a written quote to replace five bad poles on Ann Street.

President Dempsey questioned the process of posting delinquent customers houses when residents don't pay their utility bills. Petrozino explained the reasoning and legal process for this posting.

President Dempsey asked Petrozino to secure a price quote to install surveillance cameras at the swimming pool.

Carol Sutzko, Borough Treasurer, announced the reimbursement money has been received from FEMA for the abutment repairs at the Lawton Street Bridge.

Secretary Price reviewed the July 2023 Secretary'S Notes.

- The FEMA funds in the amount of \$222,223 have been received for the repairs to the Lawton St. Bridge. The
- The administrative payment (Z-time) for the FEMA project will be received by July 10TH in the amount of \$21,000.

A request for an appraisal for a small sliver of land adjacent to the John Siney Park was sent to Holden Realty. This parcel, when acquired, will be used for Handicapped Parking for John Siney Park. Grant applications will be looked at more favorably with handicap parking.

- A request from Pool Manager Debbie Piccioni for an employee party at the pool either the last day the pool is open, after hours or the following day. She is willing to donate food and ask some businesses if they would like to.

Councilwoman Judy Stednitz-Julian requested and received 4 large bags of Pierogies as a donation for the swimming pool's concession stand from Representative Twardzwick.

A list of completed conservership properties was requested for the July council meeting. These properties are ready to be sold and returned to the tax rolls.

An issue with Barn Alley was discussed and it will be followed up at the July Council Meeting..

Pledge of Allegiance

Councilperson Joann Brennan read the council prayer.

President Dempsey called to order the July 2023 monthly council meeting.

Copies of the minutes of the previous council meeting have been given to Mayor Tomko and borough council members, are there any errors or corrections? If not, they stand approved.

PUBLIC COMMENT

Rick McShaw appeared as a follow up to the ongoing neighbor issue on Fairview Street. He questioned what the next step would be since the citation was served to Michelle Brew. Attorney Brennan said Michelle Frew has 30 days to respond to the citation by either correcting what was requested in the citation or filing an appeal. The process was reviewed by Attorney Brennan.

President Dempsey read a letter written by Shannon Lafey commending the pool employees of their quick action when she was stung by a bee.

MAYOR'S REPORT

On a motion made by T. Dempsey, seconded by C. Dempsey, to accept the mayor's report; approved.

Mayor's Report

1. Residents of St. Clair who own firearms of any type should keep their firearms in a secure location within their home. Firearm owners should

make note of the Make, Model, and Serial Number of their firearms in the event of theft.

2. As vacation time is now upon us, residents are reminded that they may obtain a Vacation Form from the St. Clair Police Department. Once the form is filled out and returned to the police department, the police could increase patrols and contact the residents should there be an emergency with their property. Forms may be obtained by calling 570-429-2240 or 570-429-3050 as well as on the St. Clair Borough website.

Historical Note

The Miners Supply Company of St. Clair was engaged in the manufacturing of squibs for use by miners in firing their blasts. The idea was first suggested to Samuel H. Daddow by Jesse Beadle. The invention was perfected and patented and the manufacturing plant was built around 1866. The squibs were made and packed by hand and all of the work was done by women.

Around 1883 George Hayes opened a squib factory. He died in 1890 and his sons held the business together for a few more years after which the business closed.

The Daddow and Beadle concern operated for more than 62 years. With the use of dynamite and fuse, the squib was no longer required for mining. The Miners Supply Company of St. Clair, owned by Daddow & Beadle closed its doors in 1928.

SOLICITOR'S REPORT

Attorney Brennan reviewed the properties under conservatorship.

21 Pike Street – waiting on a hearing to approve the sale

146 N. Nicholas Street – Attended an all-day hearing with the attendance of Engineer Brian Baldwin and Structural Engineer Dave Miller of Alfred Benesch, Code Enforcement Officer Michelle Brestowski and Roland Price. He attested that they all did a great job testifying. The judge entered an order approving the Borough's final claim for demolition because there is no feasible alternative.

212 Cherry Street and 307 E. Railroad Street – Ordered the Borough as conservator. Entry will be gained to see if the properties can be rehabbed.

An executive session was requested to discuss the sale of 438-440 S. Front Street as well as 26 S. Front Street. The judge will have to approve such sale.

The Hulet property – The adult children from the prior marriage were contacted, they want nothing to do with this property. Notices were sent out to collect costs and for the attorney fees. An estate should have been set up in order for the property to be passed from one person to the next, this did not happen.

The threatening letter written by Joseph M. Maucailla was discussed concerning the sliver of land next to the John Siney Park. Attorney Brennan offered to discuss the situation with him.

Employee George Rennick will officially retire.

Mr. Altshuler at 113 E. Hancock Street agreed to negotiate the sale of 115 E. Hancock Street. The parcel will need to be appraised.

Solicitor Brennan requested an executive session of council to discuss personnel matters and pending litigation.

On a motion made by T. Dempsey, seconded by Adamchick, to accept the report; approved.

President Dempsey requested Attorney Brennan move forward in adopting a solar ordinance.

ENGINEER'S REPORT

On a motion made by Klazas, seconded by Brennan, to accept the report and to make it part of the minutes by reference; approved.

The road caving in the garage of Eleanor Jamosky of Barn Alley was discussed. The Code Enforcement Officer will send a notice of violation to the owner.

On a motion made by T. Dempsey, seconded by Adamchick, the report was unanimously approved and it was made part of the minutes by reference.

On a motion made by Klazas, seconded by C. Dempsey, the report was unanimously approved and it was made part of the minutes by reference.

POLICE REPORT

Chief Dempsey requested that Council request the Police Civil Service Commission to begin the process to conduct a non-competitive examination to fill the position of Sergeant. Only one qualified policeman in the department has all the necessary requirements to fulfill the position. Other officers have approached the Chief in support of this one qualified officer. Engineer Brian Baldwin and the Chief are working on details for the police equipment grant. The used Charger

will be sold to cover the costs of the current Tahoe expenses, for example, the cameras that aren't covered by the grant.
 The Chief requested that council make a motion to formally hire part-time officer Owen Webber.
 On a motion made by Klazas, seconded by Stednitz-Julian, the report was unanimously approved, and it was made part of the minutes by reference.

President Dempsey added the Police Department and the owner of the Trading Post have had multiple amicable conversations and he is pleased with the outcome. The Chief said the owner was very cooperative concerning the parking and trailers near his business. The problem may start to resolve itself.

ZONING REPORT – On a motion made by T. Dempsey, seconded by Adamchick, the report was unanimously approved, and it was made part of the minutes by reference.

A deck on the property on Lawton Street was discussed with the zoning officer. It was concluded that the zoning officer will try to reach out to the resident again. A question came up concerning a complaint listed on the Zoning Report from 6/23/2023. Discussion ensued of whether it is a zoning or a police issue. Chief Dempsey mentioned they are investigating noise and noticed zoning issues at the former ambulance building. Hours of operation and parking were discussed. Attorney Brennan suggested Lehigh Engineering or possibly Jerry Farro assist since there may be zoning or building code issues.

Dear St. Clair Borough Council/Code Enforcement,

I am writing today to bring up the issue of the property (formerly 132 South 2nd Street St. Clair, PA) that sits next to my house (130 South 2nd Street). The property was knocked down over a year or so ago and has yet to be filled in. This is a safety hazard not only to the public walking by on a daily basis (there is no fence up keeping people from falling in the hole or from going onto the property) but to my nieces and nephews who are small that come to visit (it only takes a quick minute for something to happen) and to my neighbors on the other side of the property who also have small children. Also, not only is it a hazard, it makes the street look like a dump. I take pride in my home, but I am tired of the property not being taken care of and looking a mess on a daily basis. I feel like I live next to a dump. It should have been filled in when the building was knocked down. I am also tired of hearing other people who walk by (when I am sitting on my porch) commenting on how bad the property looks. My response to them is "I agree and please call the borough to complain." I had called back at the end of May to inform the borough that the grass on the property was very high and needed to be cut (I have 2 dogs and again my nieces and nephews who come to play and I am worried about snakes and other animals that the high grass would attract, and it was also coming in through my fence). A few weeks went by with nothing being done and then my neighbor that is connected to my house took it upon himself to cut the grass as a nice gesture due to knowing that either side of the property has children and dogs who like to be in the yard. Again, it was not his job to do, it's the property owners' job or maybe even the borough's job to make sure the property is maintained. I am pretty sure the issue of the grass would have been taken care of by July 15, 2023, since the Car Cruise is that day (things seem to get done when there is a community event that brings others to our town). I would like this issue of the property being maintained and filled in to be placed on the agenda for the next borough meeting so the issue can be discussed. I would also like to be informed of the outcome of the issue with the property once it's discussed.

The following is the status of engineering services performed by our firm as of this date:

ENGINEERING CONSULTATIONS & CONSTRUCTION PROJECTS

Property Maintenance Activities (31311.70; 31433.02 Task 6)

We are working with the Borough Secretary, Code Enforcement Officer, and Solicitor to address multiple properties intended for demolition using both County and Borough funds. We have been working with Mr. Charles Altshuler, owner of adjoining properties of 113 E Hancock St, in preparation for its demolition. Initially, 113 and 115 were one house. Over the decades, the home was converted into two residences in various forms, complicating the demolition.

We have also been assisting the Borough with the demolition of 146 N Nichols St, attending a court hearing on May 11, 2023, and another on June 20, 2023. The County will administer this demolition once all conservatorship items are addressed.

Schuylkill County HBR Project

On June 14, 2023, the County received bids for the St. Clair Handicap Barrier Removal (HBR) project to install ADA push button power operation of the exterior door as well as the double-door to Council Chambers (the Council Chambers doors will be replaced with new doors, while the existing exterior door will remain). Two bids were received, and the County has awarded the base bid to the lowest qualified bidder Bognet, Inc. in an amount of \$68,750.00. The County is handling contract and construction administration. However, the contractor is required to coordinate all work with the Borough.

Grant Assistance (31433.02, Task 5)

Our office has been working with the Chief of Police in satisfying PCCD requests for further information associated with the grant the Police Department received. We will continue to work to address those requests and will assist with PCCD's quarterly reporting requirements.

Additionally, we have been assisting the Borough with receiving updated price quotes associated with the LSA grant to purchase a new garbage truck.

Zoning Officer Assistance (31433.02, Task 3)

Our office has been assisting the new Borough Zoning Officer with various zoning reviews, including the issues associated with 500 Fairview St.

County Hazard Mitigation Planning Process

On May 30, 2023, the County sent a letter to all municipalities informing them that the County will be working to update the *Schuylkill County Hazard Mitigation Plan* (current plan will expire on March 19, 2024). The County requests that you:

1. Complete the "Authorization and Letter of Intent to Participate" and return it to Susan Smith.
2. Designate primary and alternate points of contact (preferably a Borough Official, not just the municipal engineer).
3. Attend the kick-off meeting (date to be determined).

This will be an 8-month process. The Borough's Floodplain Manager would be a good candidate for one of the points of contact.

SUBDIVISIONS & LAND DEVELOPMENTS

Taco Bell LD (30567.32, Task 2)

The last major outstanding item of work to be performed by the Developer is the paving of the pathway along Mill Street to Taco Bell. This path might become a part of the Schuylkill River Trail. Nevertheless, Taco Bell has been in operation since late 2015. We have reached out to CCCC for a status update several times, but they have not provided any updates.

Coal Creek Commerce Center – Phase III LD (30839.32, Task 2)

As of early 2019, work in the area of the medical office building is essentially complete, although a majority of the remainder of Phase III – including stormwater features – has not yet been started. The NPDES Permit associated with Phase III was set to expire on June 28, 2023. There are three (3) more buildings and associated infrastructure yet to be completed. We have reached out to CCCC for a status update several times, but they have not provided any updates. However, in discussions with the Count Conservation District, they were told that CCCC will be submitting a permit time extension request (typically granted for 12 months).

STS LD (31137.31, Task 1)

Although STS has occupied the facility, some site work related to the detention basin is an outstanding punch list item. We will continue to monitor progress before closing out the project.

AutoZone LD (31137.31, Task 3)

The land development plans have now been recorded, and construction activities have begun. We will continue to monitor the project as construction progresses.

I would like this issue of the property being maintained and filled in to be placed on the agenda for the next borough meeting so the issue can be discussed. I would also like to be informed of the outcome of the issue with the property once it's discussed.


