ISSUES. REVIEW & FINANCE WORK SESSION

July 27, 2023

A special meeting of the St. Clair Borough Council was held to review issues and finance on Thursday, July 27, 2023, beginning at 6:30 p.m.

In attendance were council members: Thomas Adamchick, Joann Brennan, Cheryl Dempsey, Judy Stednitz-Julian, Tony Klazas, and President William Dempsey. Absent were Mayor Tomko and Thomas Dempsey.

Others in attendance included Borough Secretary Roland Price, Barbara Artz, Electric Light Superintendent Bob Petrozino, and Engineer Brian Baldwin.

Public Comment

No public comment.

In regard to the Comcast project, Electric Light Superintendent Bob Petrozino stated Wrights Electric Construction submitted a proposal that was verbally accepted by Comcast. Peter from Cable Services proposed to not only bore holes for underground conduit for Comcast, but to provide a spare conduit for the fire box at Woodland Terrace.

On another note, to provide electricity to Boone Park, Petrozino would like to get a quote from Cable Services to direct bore holes to run electricity to each of the trees as well as the two lamp posts that haven't yet been erected but purchased for Boone Park in memory of Sean Mettam. The Electric Light Department would then run the wire. Boring holes will prevent the grounds from being ripped up in the park. Secretary Price added that the local Actors Guild is utilizing the park and having light would enhance the atmosphere of the park. Otherwise, a ditch witch would have to be rented to slice the ground in order to install the electric lines.

Petrozino added, Comcast asked for traffic control in certain areas while the poles are being maintained. Petrozino agreed to traffic control. Restoration of pole holes and sidewalks are being considered by the Borough at a cost to Comcast.

Engineer Brian Baldwin presented the Engineer's monthly report as it is made part of the minutes by reference.

Borough Secretary's Notes

On September 26, 2023, The Police Civil Service Commission will administer the test to Brad Blanner for the position of sergeant. The test booklet and study guide are on order. Municipal audits are quite extensive, and Jones & Co. do not have the manpower to continue providing service to us. Right now a request has been made to Cheri Freeh, CPA, CGMA.

ENGINEERING CONSULTATIONS & CONSTRUCTION PROJECTS

Property Maintenance Activities (31311.70; 31433.02 Task 6)

We are working with the Borough Secretary, Code Enforcement Officer, and Solicitor to address multiple properties intended for demolition using both County and Borough funds. We have been working with Mr. Charles Altshuler, owner of adjoining properties of 113 E Hancock St, in preparation for its demolition. Initially, 113 and 115 were one house. Over the decades, the home was converted into two residences in various forms, complicating the demolition.

Schuylkill County HBR Project

On July 18, 2023, a preconstruction meeting was held with Bognet and County officials. The project is currently in the submittal phase. Construction is expected to occur in late September, and the contractor is required to coordinate all work with the Borough.

Grant Assistance (31433.02, Task 5)
