#### **Historical Note**

The first Ice Plant powered by electricity was established in June 1921 by Joseph Grosskettler and Burton Davis. In later years, and ice plant was operated by Mr. Tom Brown and was located on Third Street. This business ceased operations in the 1960's.

Previous to electric powered ice plants, the Ferrebee family obtained a lease to cut and store ice at Silver Creek Dam. This ice was delivered to locations in St. Clair by horse and wagon.
