## St. Clair Borough News Bulletin November 2024

We will no longer be collecting refrigerators, freezers, air conditioners, or any item containing freon.

St. Clair Dairy was organized on October 1, 1922 under the proprietorship of Edward Honicker and Walter Stephens. By 1933 the dairy had grown to have 19 employees and eight delivery trucks.

The St. Clair Dairy ceased to operate in the late 1960's or early 1970's.
