

## ISSUES, REVIEW & FINANCE WORK SESSION

October 28, 2025

A special meeting of the St. Clair Borough Council was held to review issues and finance on Tuesday, October 28, 2025, beginning at 6:30 p.m.

In attendance were Council Members Joann Brennan, Cheryl Dempsey, Norm Diehl, Judy Stednitz-Julian, Tony Klazas, Patrick McCord, President Thomas Dempsey and Mayor Tomko.

Others in attendance included Borough Manager Roland Price, Treasurer Carol Sutzko, Electric Light Superintendent Bob Petrozino, Street Superintendent Kevin Dempsey, Acting Police Chief Brad Blanner, Barbara Artz, Vaughn Vesay, Mike Petrozino, Tom Kelly, Blake Herndan, John Zachur and Tony Sylvester.

### PUBLIC COMMENT

Council candidate Tom Kelly wished good luck to all candidates and congratulations to newly appointed Councilman Patrick McCord. Council also wished everyone good luck.

Mayor Tomko declared November 2025 to be "Mettam Brothers Lumber Company Month" with a proclamation in honor of their 140<sup>th</sup> anniversary in business. He added that there will be an Ecumenical Thanksgiving Service on Sunday, November 23 at 5 p.m. at the Presbyterian Church. He requested this be placed in the newsletter. He advised that the Resolution opposing BRADS Landfill and the Ordinance regulating data centers and to preserve the quality of life for the borough that was presented by Mrs. Portland at the last council meeting be considered by council and given to the solicitor to review. He also inquired about the tree on the property that is neighboring the Cheripka property. Borough Manager will investigate this situation.

Councilman Diehl asked if we could share the proposed ordinance with surrounding communities, Mayor Tomko stated that once it was a passed ordinance and written in the law books, anyone has access to it. Council member C. Dempsey added they were probably already looking into this type of ordinance.

Treasurer Carol Sutzko said the Borough's finances are doing good.

Borough Manager Roland Price reviewed his notes as follows.

A copy of the Budget Hearing schedule is attached for council's review.

Responses to the Game of Skills Ordinance have been received. Eight businesses have responded resulting in \$32,500 collected in revenue. One business failed to respond. A follow-up letter has been sent to them. Numerically numbered stickers must still be purchased and placed on each machine.

Interviews were held for the position of Assistant Electric Light Lineman. One applicant is still interested in the position which will be discussed in executive session.

The Compensation Time Policy is attached for review and possible adoption at the November Council meeting.

An executive session of council is requested to discuss personnel matters.

Council Member C. Dempsey inquired if there is a time limit extended to the business that hadn't responded yet. Council Member Klazas asked if the licensing was good for year. Manager Price said he will be on top of the business and yes, good for one year.

Council members Diehl and Brennan clarified the Compensation Policy details Street Superintendent Kevin Dempsey asked for an executive session for personnel reasons.

Electric Light Superintendent Bob Petrozino revealed that the radar speed sign on East Hancock Street, that had been attached to the pole for approximately 10 years was found at the base of the pole, by the police, and eventually due to a mix up, was thrown in the garbage. With the help of the police, there is no proof of how this incident originally happened. Since it was acquired through a grant, he was questioning if it was under insurance or if we can get another one through a grant. Council member C. Dempsey mentioned that possibly Engineer Baldwin could acquire another grant for one. The cost is approximately \$6,000. Council commended Petrozino, Lineman Rudy Grubbs and PPL for a great job in restoring the power outage. Petrozino added that he has a great relationship with PPL and mentioned to them the potential issues with overgrown vegetation and the reliability of the aging power lines.

Acting Police Chief Brad Blanner requested an executive session to discuss personnel issues.

Councilman Diehl asked if Senate Bill 194 can be looked in to especially considering the costly expense to place an advertisement in the Pottsville Republican.

President Dempsey announced that Trick or Treat has been moved to Saturday, November 1 from 6 to 8 p.m. due to impending inclement weather.

The executive session began at 6:45 p.m. to discuss personnel matters.

The executive session ended, and the council meeting adjourned at 7:21 p.m.

**NOVEMBER COUNCIL MEETING****November 6, 2025**

The November monthly Council Meeting of the St. Clair Borough Council was held on Thursday, November 6, 2025, in Council Chambers, St. Clair Municipal Building, 16 S. Third Street, St. Clair. The meeting began at 6:30 p.m.

Answering the roll call were council members: Joann Brennan, Cheryl Dempsey, Norm Diehl, Judy Stednitz-Julian, Patrick McCord, Council President Thomas Dempsey and Mayor Tomko. Absent was Council Member Tony Klazas.

Also, present included Solicitor Ed Brennan, Borough Engineer Brian Baldwin, Borough Manager Roland Price, Treasurer Carol Sutzko, Acting Police Chief Brad Blanner, Fire Chief Frank Uhrin, Code Enforcement Officer Michelle Brestowski, Barbara Artz, Tom Kelly, John Zachar, Mike Petrozino, Blake Herndon, Mike Jackson, Joe Jusinski, and Vaughn Vesay.

**Pledge of Allegiance**

Council member Joann Brennan read the council prayer.

President Tom Dempsey thanked all the candidates who ran for council and congratulated those who were elected.

Copies of the minutes of the previous meetings have been given to borough council members and Mayor Tomko, are there any errors or corrections? If not, they stand approved.

**PUBLIC COMMENT**

Joe Jusinski was concerned when casting his vote, he felt obligated to vote for Stednitz-Julian or the community pool would close. He asked if

- 1.) Was it a lie?
- 2.) Will he now be blacklisted from the pool for speaking out, and
- 3.) Is this true? He feels he should not have been told that when in line to vote. Stednitz-Julian denied making that statement. Mayor Tomko stated that the pool was 70 years old and numerous council people have endeavored to keep the pool open, he will continue to do whatever he can to keep it open.

John Zachar also questioned the pool situation. He stated that data centers were being considered for surrounding municipalities, and that property was sold for a data center in New Castle Township. Discussion concerning data centers ensued. A sample ordinance was given to the solicitor to review. Solicitor Brennan stated that to amend the zoning ordinance was a lengthy process. Since there is no property within the borough boundaries, it doesn't warrant adopting an ordinance. Zachar wants to get surrounding communities involved in opposing data centers. Mayor Tomko encouraged council to support the proposed resolution opposing data centers in the area.

Mike Jackson congratulated the elected officials. He also spoke on behalf of his neighbor who apparently heard comments concerning the closing of the pool. He felt that it was an advantage of the candidate to use the tax payer public pool towards her campaign. He feels there should be an investigation because it wasn't fair to the other candidates to use this platform to her advantage. Going forward he encouraged the new council to continue to discuss the challenges of the electric system, the landfill, data centers and most importantly the police shortfall. He also congratulated Patrick McCord on being appointed to fill the late Bill Dempsey's seat on council for the remainder of the term.

#### **SOLICITOR'S REPORT**

The Solicitor enlightened everyone by explaining that during the recent baseball World Series, the record setting Blue Jays pitcher, Yesavage, has ties to Schuylkill County, particularly to St. Clair through the Gargano family. An unusual Right to Know video request was processed with the assistance of Chief Blanner. A great amount of time was spent on this request which was denied. People look to obtain these videos to post on line, which is unlawful. The Comp Time Policy was completed and will be reviewed in executive session. The two Customer Owned Generation Ordinances are in the final stages of being reviewed by a third-party expert.

The Firehouse Grant seems to be more simplified than first anticipated. No paperwork beyond the \$400,000 is necessary.

The solicitor reviewed the list of conservatorships. Many are on the launch pad of being settled. (311 Broad Street, 601 Wade Road, 26 S. Front Street)

438 S. Front Street – Hearing later this month to approve the settlement.

30 Thompson Street – Hearing in October, the judge granted more time to address the improvements they need to make. Compliments to Code Officer Brestowski, Benesch and Jeff Farro for the work and expertise they provided to the case. The lender has now gotten involved. The next hearing will be in January. The Barn Street property has also begun the conservatorship process.

The Solicitor requested an executive session to discuss litigation matters. On a motion by C. Dempsey, seconded by Brennan, the report was unanimously approved, and it was made part of the minutes by reference.

### **ENGINEER'S REPORT**

On a motion made by C. Dempsey, seconded by Diehl, the report was unanimously approved, and it was made part of the minutes by reference.

Solicitor Brennan also reviewed the property owned by the estate of Pat Davies. Follow up next month.

Council Member Diehl questioned the solicitor about the process of the ordinance for the data center. The solicitor explained the unnecessary cumbersome process due to the fact that a data center cannot be built in the borough, it can be done, but it's not practical. Diehl wants to be sure that the St. Clair Borough follows the surrounding communities opposing the data centers regardless of the work involved. Mayor Tomko asked if we could adopt a resolution opposing a data center not only in St. Clair but in Schuylkill County, similar to the resolution opposing the landfill. The solicitor will draw up a resolution specific to the proposed data center in New Castle Township for the next council meeting.

On a motion by McCord, seconded by C. Dempsey to appoint the Borough Manager and the Treasurer as the liaison with Berkheimer, the duly appointed collector of local taxes for the district, for the express purpose of sharing confidential tax information with the district for official purposes (Resolution attached.), approved.

The following is the status of engineering services performed by our firm as of this date:

#### **ENGINEERING CONSULTATIONS & CONSTRUCTION PROJECTS**

##### **Firehouse Addition (0325-609049.02, Task 7)**

To the extent requested, our office will assist the Borough and the Fire Company with preparing the project bid package and soliciting bids. Once the project is awarded, we anticipate Yourshaw and/or the Fire Company representatives will be performing most progress inspections with Benesch handling minor administrative efforts associated with grant coordination.

##### **Northward Basketball Courts (0000-031433.20)**

##### **Youth Basketball Court (0325-609049.21)**

Earlier this year the Borough received a PA DCED CFA Greenways, Trails, Recreation Program (GTRP) grant in the full-requested amount of \$64,175 to construct a youth basketball court adjacent at the Third Street Playground. We intend to bid this project at the same time as the Northward Playground project since both are similar in scope. We anticipate receiving bids in December or January with construction beginning in the spring.

##### **SR 61-14M PennDOT Project (0325-609049.70, Task 5)**

PennDOT intends upgrade the traffic signal controller at the Terry Rich Blvd intersection as part of their Frackville Grade project. Any existing equipment removed is Borough property and should be returned to the Borough if desired. We were provided the PennDOT plans for this signal upgrade after a PA One Call was initiated with the Electric Light Department. The proposed equipment is compatible and with the Borough's standards regarding uninterrupted power supply (battery backup) as well as emergency generator hookup.

##### **Property Maintenance Assistance (0325-609049.70, Task 3)**

Our office has been providing assistance to the Borough and the Solicitor regarding property maintenance and conservatorship activities, including attending the latest hearing held on October 20, 2025, relating to 30 Thompson Street.





**RESOLUTION NO. 6-2025**

**A RESOLUTION REAFFIRMING THE BOROUGH OF SAINT CLAIR'S OPPOSITION TO THE  
ONGOING OPERATIONS OF THE BRADS LANDFILL AND RECOGNIZING THE  
COMMUNITY'S RIGHT TO CLEAN AIR, PURE WATER, AND A SAFE ENVIRONMENT**

- WHEREAS, the Borough of Saint Clair, Schuylkill County, Pennsylvania, is a Fenceline Community located immediately adjacent to the BRADS Landfill, owned and operated by Waste Connections, situated in Blythe Township, Pennsylvania; and
- WHEREAS, the Borough recognizes its duty to protect the health, safety, and welfare of its residents and to preserve the integrity of the surrounding environment; and
- WHEREAS, the Borough of Saint Clair has been identified as an Environmental Justice Area under the Pennsylvania Department of Environmental Protection's Environmental Justice Mapping and Screening Tool (PennEnviroScreen), a state-of-the-art tool that uses more than thirty (30) environmental, health, and socioeconomic indicators to identify communities facing disproportionate environmental burdens and cumulative impacts; and
- WHEREAS, Article I, Section 27 of the Pennsylvania Constitution, entitled 'Natural resources and the public estate,' provides that:  
"The people have a right to clean air, pure water, and to the preservation of the natural, scenic, historic and esthetic values of the environment. Pennsylvania's public natural resources are the common property of all the people, including generations yet to come. As trustee of these resources, the Commonwealth shall conserve and maintain them for the benefit of all the people."

(Adopted May 18, 1971, P.L.769, J.R.3)

- WHEREAS, the Borough of Saint Clair affirms that this constitutional right extends to all residents and that local government plays an essential role in upholding these protections within its jurisdiction; and
- WHEREAS, the BRADS Landfill's ongoing operations have resulted in continuing hydrogen sulfide (H<sub>2</sub>S) emissions, increased heavy truck traffic on community roadways such as Burma Road, and persistent environmental and public health burdens that adversely affect nearby residents, local schools, and businesses; and
- WHEREAS, the Borough of Saint Clair is a small, historic, and residential community with school bus routes, Schuylkill Transportation System (STS) transit routes, and high local traffic volumes along Burma Road, making landfill-related truck activity a direct threat to public safety and community welfare; and
- WHEREAS, these impacts are inconsistent with the Borough's goals for community safety, public health, and quality of life, as well as with the spirit and intent of Article I, Section 27 of the Pennsylvania Constitution; and
- WHEREAS, the Borough Council recognizes the cumulative environmental and economic strain placed upon Saint Clair and its residents as a direct result of the landfill's proximity and continued expansion of operations.

*NOW, THEREFORE, BE IT RESOLVED by the Council of the Borough of  
Saint Clair, Schuylkill County, Pennsylvania, as follows:*

1. 1. Reaffirmation of Opposition: The Borough of Saint Clair hereby reaffirms its opposition to the ongoing operations of the BRADS Landfill and to any future expansion, permit modification, or activity that would further endanger public health, safety, or the environment.
2. 2. Environmental Stewardship: The Borough stands in support of Article I, Section 27 of the Pennsylvania Constitution and asserts its commitment to safeguarding clean air, pure water, and a safe environment for present and future generations.
3. 3. Environmental Justice Commitment: The Borough acknowledges its designation as an Environmental Justice Area and demands equitable environmental protections and meaningful public involvement in all decisions affecting the community's health and environment, consistent with Pennsylvania's Environmental Justice Policy.
4. 4. Notification and Advocacy: The Borough Secretary shall forward a certified copy of this Resolution to:
  - The Pennsylvania Department of Environmental Protection (DEP)
  - Schuylkill County Commissioners
  - Blythe Township Board of Supervisors
  - The Pennsylvania Department of Health
  - State and Federal elected representatives serving the Borough of Saint Clair
5. 5. Public Engagement: The Borough encourages residents and neighboring municipalities to remain engaged in environmental review processes, report odor and safety concerns, and participate in DEP public comment and hearing opportunities.
6. 6. Effective Date: This Resolution shall take effect immediately upon adoption.

WHEREAS, Act No. 511 of the 1965 General Assembly of the Commonwealth of Pennsylvania (53 P.S. §6901 et seq.), enacted December 31, 1965, and effective January 1, 1966, authorizes certain political subdivisions, including St. Clair Borough, Schuylkill COUNTY, to provide for the creation of such bureaus or the appointment and compensation of such officers, clerks, collectors and other assistants and employees as may be deemed necessary for the assessment and collection of taxes imposed under the authority of that Act; and

WHEREAS, St. Clair Borough, Schuylkill COUNTY, has entered into contractual agreement with BERKHEIMER of Bangor, Pennsylvania, whereby and whereunder St. Clair Borough appointed Berkheimer to collect certain local taxes; and

WHEREAS, said Act 511 specifically mandates that any information gained by the appointed tax officer, his agents or by any other official or agent of the taxing district, as a result of any declarations, returns, investigations, hearings or verifications required or authorized by the taxing municipality's ordinance or resolution, be kept confidential, except for official purposes; and

WHEREAS, any person who divulges any information which is confidential under the provisions of any ordinance or resolution, upon conviction may be subject to fines and/or imprisonment, upon conviction, and dismissal from office or discharge from employment; and

WHEREAS, Berkheimer requires passage of a resolution by the governing body of St. Clair Borough, Schuylkill COUNTY specifying that said confidential information is needed for official purposes and absolving Berkheimer from any liability in connection with the release of said confidential information;

**NOW, THEREFORE, BE IT RESOLVED** that:

1. St. Clair Borough, Schuylkill COUNTY hereby appoints Borough Manager or Borough Treasurer as its authorized representative to make (Job Title) requests upon and receive any and all tax information and records from Berkheimer, relative to the collection of taxes for St. Clair Borough, as desired and deemed necessary by St. Clair Borough, to be used for official purposes only; and

2. Berkheimer is hereby directed to provide and/or transmit any and all tax information and records, or any portion thereof, relating to the collection of taxes for the St. Clair Borough, upon request, to Borough Manager or Borough Treasurer as the authorized contact (Job Title) representative for it.

3. St. Clair Borough, Schuylkill COUNTY hereby saves harmless, indemnifies and/or absolves Berkheimer from and against any and all liability in connection with the release of said confidential information.
